### ARTICLES OF ORGANIZATION OF MEDGENDA, L.L.C.

The undersigned, for the purposes of forming a limited liability company under the Horida Limited Liability Company Act, hereby make, acknowledge and file the following Articles of Organization:

#### ARTICLE I - NAME
