The Limited Liability Company is to be a member managed company.


ARTICLE VIINITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

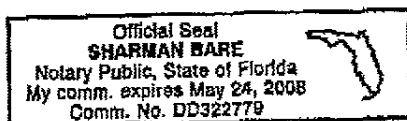
