**ARTICLES OF DISSOLUTION

Pursuant to the provisions of Section 605.0707 of the Florida Limited Liability Company Act, as amended, the undersigned limited liability company adopts the following Articles of Dissolution for the purpose of dissolving the limited liability company:

1. The name of the limited liability company is Sunstream Lane Development, LLC (the "Company").
2. The Articles of Organization of the Company were filed on November 9, 2006, and assigned document number L06000109486.
3. The effective date of the Company's dissolution is the date these Articles of Dissolution are filed with the Florida Department of State.
4. The dissolution of the Company was authorized by the unanimous written consent of the members on September 17, 2021, which, in addition to the fact that the Company has sold substantially all of its assets, are the occurrences that resulted in the Company's dissolution.
5. Adequate provision has been made for the debts, obligations and liabilities.
6. All remaining property and assets have been distributed to its members in accordance with such member's rights and interests.
7. No suits are pending against the Company in any court.
8. These Articles of Dissolution may be executed in counterparts, each of which when so executed shall be deemed to be an original, and such counterparts together shall constitute one and the same instrument, which shall be sufficiently evidenced by any such original counterpart.
