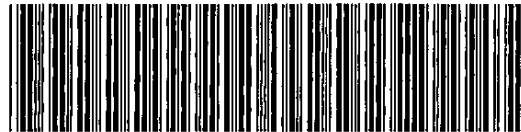

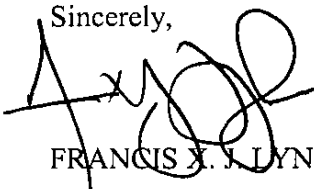

ARTICLES OF ORGANIZATION FOR
SARSON IVA, LLC, A FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I – NAME:

The name of the Limited Liability Company is SARSON IVA, LLC (the "Company").

ARTICLE II – PURPOSE:

- A. The Company is organized for the primary purpose of fostering national and international volleyball competition (no part of the activities of which involve the provision of the athletic facilities or equipment) and for other similar purposes under Internal Revenue Code Section 501(c)(3). The Company is also organized for other not-for-profit purposes, substantially all of the activities of which are for the aforementioned purposes and no part of the net earnings of which inures to the benefit of any manager or member.
- B. In the event of a dissolution of the Company, the net assets thereof, after payment or other provision is made for any and all indebtedness and other liabilities of the Company, shall be delivered and paid over to an organization selected by the then managing member(s) which qualifies as an Exempt Organization under Section 501(c), or similar section, of the Internal Revenue Code then in effect.

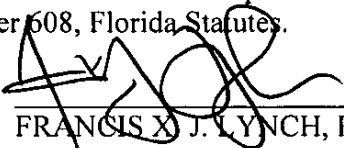

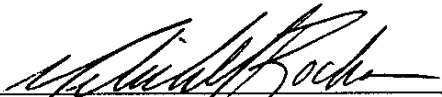
