**ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION
OF
FOUNTAINS AT OVIEDO MANAGERS, L.L.C.**

The undersigned, as Manager of FOUNTAINS AT OVIEDO MANAGERS, L.L.C., a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

1. The current name of the Company is FOUNTAINS AT OVIEDO MANAGERS, L.L.C.
2. The date of filing of the original Articles of Organization of the Company was November 13, 2006.
3. The Articles of Organization of the Company are amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

The name of the limited liability company is FOUNTAINS AT MANATEE COVE MANAGERS, L.L.C. (the "Company").

4. The Articles of Organization of the Company are amended by deleting Article II entitled "Address" in its entirety and inserting the following section in its place and stead:

The Address of the limited liability company is 329 N. Park Avenue, Suite 300, Winter Park, Florida 32789

4. This amendment to the Articles of Organization of the Company was approved by the unanimous consent of all of the members.
