2. Article I of the Articles of Organization of the Company is hereby deleted in its entirety and amended to read as follows:

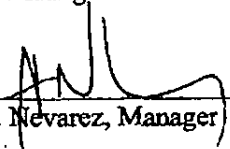

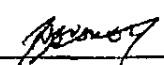
The name of the limited liability company is Rimmon Partners, LLC (the "Company")."
