FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came on to be heard on this 18 day of May, 2011 on Petitioner/Husband
WALTER CROCKETT BOHANNON's ("Husband") *Petition for Dissolution of Marriage*
(hereinafter "Petition"), and the Court having reviewed the file and being fully advised in the
premises, the Court FINDS as follows:

1. The Husband and the Respondent/Wife, DANIELLE MARIE BOHANNON ("Wife"), have been residents of the State of Florida for more than six (6) months prior to the commencement of this action.
2. The parties were duly married to each other on [REDACTED] in Las Vegas, Nevada.
3. The parties hereto are *sui juris*, and neither is a member of the Armed Forces of the United States or any of its allies.
4. The marriage between the parties is irretrievably broken.

5. There were no children born of the parties' marriage and no children are expected.

6. The parties entered into a *Marital Settlement Agreement* ("Agreement") dated [REDACTED], freely, voluntarily, and with the intent to be bound thereby. The original Agreement has been previously filed with the Court.

THEREUPON, it is **ORDERED** and **ADJUDGED** as follows:

A. The marriage between the Petitioner/Husband, WALTER CROCKETT BOHANNON, and the Respondent/Wife, DANIELLE MARIE BOHANNON, is hereby dissolved because it is irretrievably broken.

B. The Agreement is ratified, approved, and incorporated herein by reference. The parties are ordered to abide by the Agreement in every respect.

C. The Wife's maiden name, DANIELLE MARIE DRAPER, is hereby restored by this Court, and the Respondent/Wife shall hereinafter be known by her former name.
