Re: Statement of Fact – Paramount Ventures Group LLC (Document Number L06000110253)

Dear Division of Corporations:

DLA Piper LLP (US) has been retained by Paramount Ventures Group LLC (“**Paramount**” or the “**Company**”) (Document Number L06000110253), and Daniel Correa, in his capacity as Sole Member of Paramount, to represent them in connection with filings made on behalf of the Company with the Division of Corporations through Sunbiz.org by former individuals associated with Paramount.

In particular, Mario Lacourt the former Sole Manager of the Company made the following false filings in which he wrongly identified himself as the Company’s Manager:

- September 27, 2024 – Annual Report
- November 27, 2024 – Amended Annual Report
- December 2, 2024 – Amended Annual Report

In each of these submissions Mr. Lacourt wrongly identified himself as the Sole Manager of Paramount and RDM Bookkeeping Service and Consulting Corp. (“**RDM**”), the President of which is Rosemary Marks, as Paramount’s Registered Agent.

Mr. Correa is the sole member of the Company and is therefore authorized to act for the Company. On July 29, 2024, Mr. Lacourt entered into transactions as a result of which he assigned his entire interest in Paramount. As a result of these transactions, Mr. Lacourt’s former interest was transferred to Mr. Correa. As Sole Member of Paramount, Mr. Correa removed Mr. Lacourt and appointed Dexter Dwight as the Sole Manager of the Company.

At all times listed and with regard to each of the three filings identified above, Mr. Lacourt was no longer a manager, member, registered agent, or otherwise authorized to act for or on behalf of Paramount.

Concurrently with the filing of this request, Paramount and its authorized manager, Mr. Dwight, have filed an amendment correcting the Company's registration and also requested that the Company's Sunbiz.org account be frozen. Paramount also has demanded that Mr. Lacourt cease and desist from making any further false submissions with the Florida Division of Corporations and otherwise holding himself out as a person authorized to act for or on behalf of Paramount. Should Mr. Lacourt fail to comply, Paramount and its authorized representatives will seek a binding legal determination.

Nothing herein shall constitute a waiver, release, or otherwise by Paramount, Mr. Correa, or the Company's authorized representatives in connection with any claims or potential claims, including claims that may be discovered in our ongoing investigation of the conduct described herein. Paramount, Mr. Correa, and the Company's authorized representatives expressly reserve their rights to pursue any and all legal and equitable remedies available in connection with the actions mentioned above.
