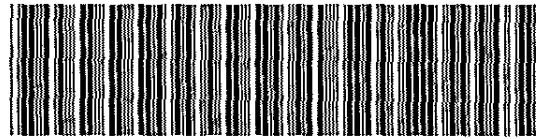



**ARTICLES OF ORGANIZATION**  
**OF**  
**DIKTANAS CONTRACTING, LLC.**

The undersigned hereby makes and subscribes to these Articles of Organization intending to form a Limited Liability Company under the provisions of the Florida Statutes.

1. **Name.** The name of the Limited Liability Company is DIKTANAS CONTRACTING, LLC. ("Company"). The Company may conduct business under that name and under any other name or names upon which the manager(s) may select with the approval of the member(s). If the Company conducts business under a name other than that set forth in these Articles of Organization, then the Company shall file a fictitious name registration, as required by law, as to each such other name.


2. **Purpose.** The Company is organized to engage in any business permitted under applicable law.

8. **Management of the Company.** The Company shall be managed by the manager(s). The following persons will initially be the manager(s):


