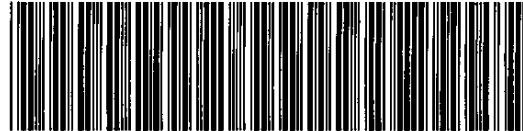

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

**ARTICLE I**  
Name

The name of the limited liability company (hereinafter referred to as the "Company") is A. BEHAR PROPERTIES, LLC.

**ARTICLE II**  
Nature of Business and Mailing Address

The Company is organized for the purpose of transacting any or all lawful business. The mailing address and street address of the principal office of the Company is 15001 Falkirk Place, Miami Lakes, FL 33016.

**ARTICLE III**  
Duration

This Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

**ARTICLE IV**  
Management:

Managed by Members. This Company shall be managed by its Members in accordance with the Regulations and Operating Agreement of the Company.

**ARTICLE V**  
Admission of Additional Members

New owners who take their interest directly from the Company will be admitted as Members. The Company shall terminate upon the consent of all Members or as otherwise provided in accordance with the terms of the Regulations and Operating Agreement.

##### **Limitation on Agency Authority of Members**

No member of the Company shall be an agent of the Company solely by virtue of being a member, and no member shall have authority to incur debt or contractual liability on behalf of the Company solely by virtue of being a member.

##### **Amendment**


This Company reserves the right to amend or repeal any provisions contained in these Articles of Organization, and any right conferred upon the Members is subject to this reservation.

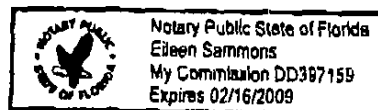
