ARTICLES OF ORGANIZATION

OF

The undersigned, being authorized to execute and file these Artistes of Organization, hereby certifies that:

ARTICLE I

The name of the limited liability company (hereinafter referred to as the "Company") is ML PLAZA, LLC.

ARTICLE II

Nature of Business and Mailing Address

Duration

This Company shall exist on the date of filing of these Articles with the Secretary of State of the State of Florida. The duration of the Company shall be perpetual.

ARTICLE IV

Management

Initial Registered Office and Agent


