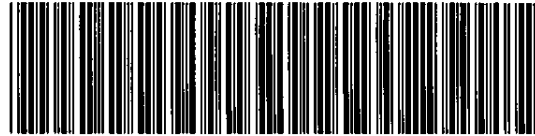

The undersigned, being authorized to execute and file these Amended and Restated Articles of Organization, hereby certifies that:

ARTICLE I - Name

The name under which the limited liability company (hereinafter referred to as the "Company") was originally filed is American Money Management, LLC, and the date of filing of the Company's original Articles of Organization with the Department of State was November 15, 2006 (document number of Company is L06000110571). These Amended and Restated Articles of Organization are changing the name of the Company to: Steele Financial Services, LLC.
