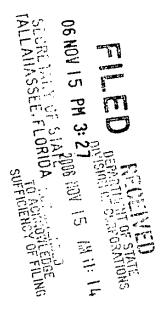

## ARTICLES OF ORGANIZATION OF CHAMELEON DESIGNS, LLC

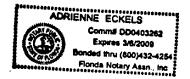

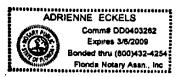
