**ARTICLES OF ORGANIZATION  
OF  
ACI 20 20 PROPERTIES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **ACI 20 20 PROPERTIES, LLC** ("Company").

**ARTICLE II - ADDRESS**

**ARTICLE III - DURATION**

The Company shall commence its existence on the date these articles of organization are filed by the Florida Department of State. 
**ARTICLE V - TERMINATION OF EXISTENCE**


