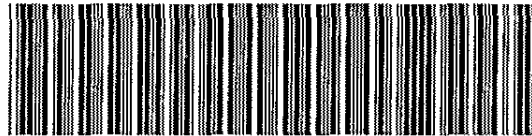

ARTICLES OF ORGANIZATION

of
