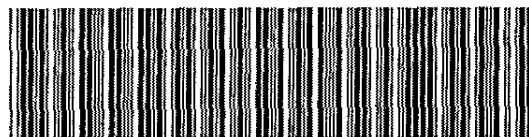

ARTICLES OF ORGANIZATION

ARTICLE I

NAME

ARTICLE VIII

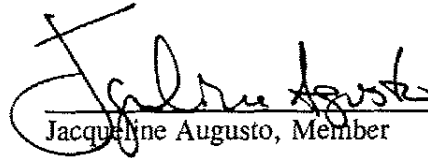
MANAGEMENT OF COMPANY
