ARTICLES OF ORGANIZATION OF CSS REALTY, LLC

A Florida Limited Liability Company

ARTICLE 1


NAME

ARTICLE 2

PURPOSE AND POWERS



B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, Florida Statutes, as the same may be amended from time to time.

MANAGER

Should the foregoing named Manager be unable to serve in this capacity, in such event the business of the Company shall be managed by a Manager elected by the Members holding seventy-five (75%) of the then outstanding contributed and not returned capital of the Company. CONTINUATION OF BUSINESS

The remaining Member or Members of the Company shall have the right to continue the business of the Company upon the retirement, resignation, expulsion, bankruptcy or dissolution of a Member.

ARTICLE 8

AMENDMENTS

The Company reserves the right to amend any provision of these Articles of Organization, which amendment shall only be effectuated by the written approval by a majority of the Members of the Company and the approval of the Manager of the Company.

ARTICLE 9

AUTHORIZED REPRESENTATIVE

. Under the provisions of the Florida Limited Liability Company Act, Susan Patneaude, a member of the Company, authorizes K. Judith Lane, Esquire, to file these Articles of Organization as an authorized representative of the Company.

ADOPTION OF OPERATING AGREEMENT

The Company may adopt an Operating Agreement which may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with these Articles of Organization, or Chapter 608, Florida Statutes.
