**ARTICLES OF ORGANIZATION
OF
CENTERPOINTE MEDIATIONS, LLC.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

ARTICLE VIII - MEMBERS RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death of a member, bankruptcy, or dissolution of a member or manager, or in the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote of the remaining members.

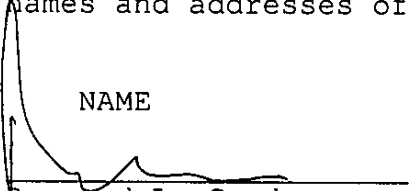
ARTICLE IX - MANAGEMENT

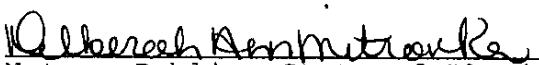

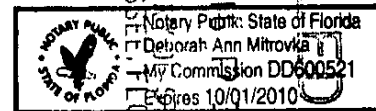

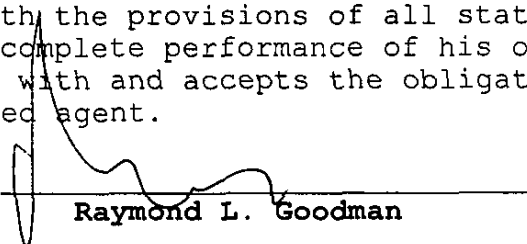
