

ARTICLES OF ORGANIZATION OF HACIENDA DEL SOL ANDALUSIANS, LLC

The undersigned for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and He the following Articles of Organization.

ARTICLE I Name
