The undersigned authorized agent of the initial Members of this limited liability company hereby certifies that the Members have associated themselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

The undersigned authorized agent further declares that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I
NAME

The name of the limited liability company shall be JEFFERS, LLC (the "Company").

ARTICLE II
ADDRESS OF PRINCIPAL PLACE OF BUSINESS

The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's Operating Agreement.

ARTICLE V
MANAGEMENT

The Company shall be member-managed in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Company. This Operating Agreement may contain any provisions for the regulation and management of the

affairs of the Company not inconsistent with law, this Instrument and the Florida Limited Liability Company Act.


ARTICLE VI


