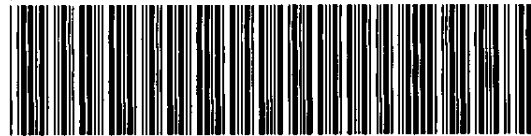

PURPOSE**

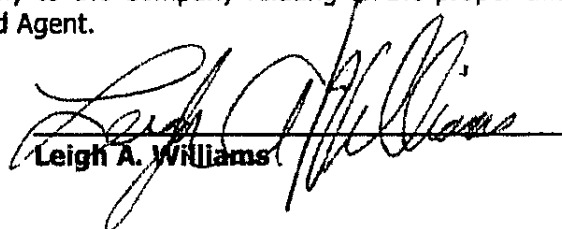
