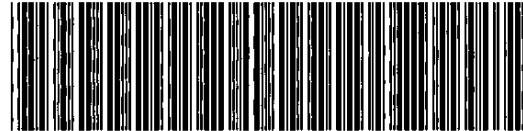

The name of the Limited Liability Company is: DECO HOLDINGS, LLC ("Company").


