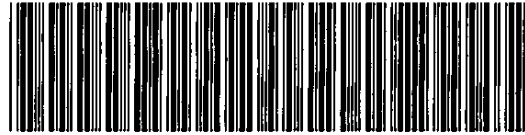



ARTICLE I

NAME

The name of this limited liability company is 24/7 SITE PREP & TRACTOR SERVICES, LLC.

ARTICLE II

PURPOSE

- A. Purposes: The company is organized for any legal and lawful purpose for which a limited liability company may be organized, pursuant to Chapter 608, Florida Statutes, as the same may be amended from time to time.
- B. Powers: The company shall have and may exercise all powers and rights which a limited liability may exercise pursuant to Chapter 608, Florida Statutes, as the same may be amended from time to time.

ARTICLE III

ADDRESS

The mailing and street address of the company's principal place of business shall be 806 SW Lauman Glen, Fort White, Florida 32038.

ARTICLE IV

DURATION

The period of duration of the company shall be perpetual. ARTICLE VII
ADMISSION OF NEW MEMBERS

AMENDMENT OF ARTICLES OF ORGANIZATION

These Articles may be amended at any time by a resolution adopted by the members, in conformity with the regulations permitting said amendment, at any annual or special meeting.

ARTICLE XI
**INITIAL ADDRESS OF REGISTERED OFFICE
AND DESIGNATION OF REGISTERED AGENT**

The street address of the initial registered office of this limited liability company in the State of Florida is 806 SW Lauman Glen, Live Oak, Florida 32038. The members may from time to time, without amending these Articles, move the registered office to any other address within the State of Florida.

The initial registered agent is designated as MICHAEL WESLEY BOYKIN. The registered agent of the limited liability company may be changed at any time by a vote of the members without an amendment of these Articles.
