The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **YOUR IDEAL LIFE RESOURCES, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2520 University Boulevard West, Jacksonville, Florida 32217 and the mailing address shall be the same.

whose addresses shall be the same as the principal office of the Company.



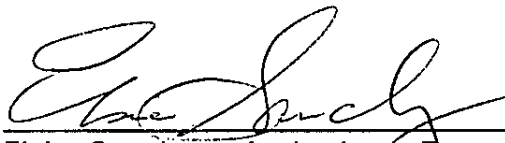

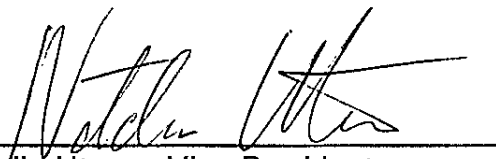
