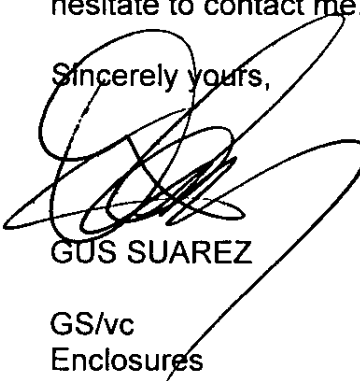

Rosa M. Gonzalez is hereby deleted as the Registered Agent of the Corporation.

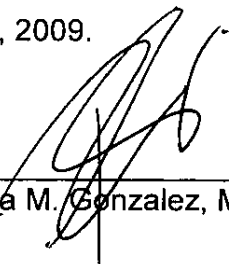

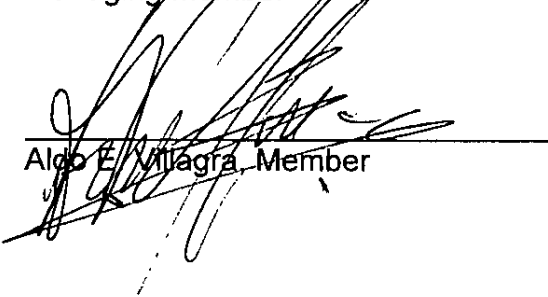

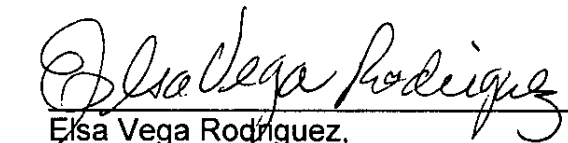
