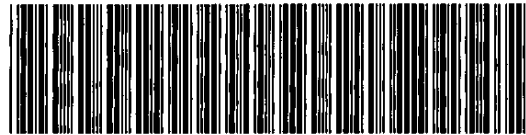



ARTICLES OF ORGANIZATION

OF

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

1. Name.

The Limited Liability Company is to be managed by the member/manager who is designated, appointed, or elected to act as the managing member.



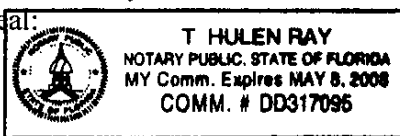
