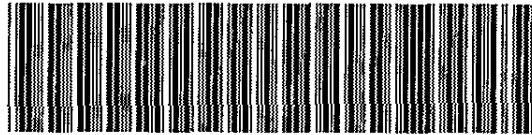

The undersigned, desiring to form a limited liability company pursuant to Chapter 689 of the Florida Statutes, executes these Articles of Organization.

ARTICLE I.

The name of the limited liability company shall be THE PARIS GROUP, LLC

ARTICLE II.

The period of duration of the limited liability company shall be perpetual.

ARTICLE III.

ARTICLE IV.

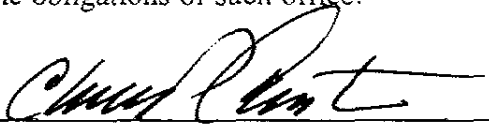
