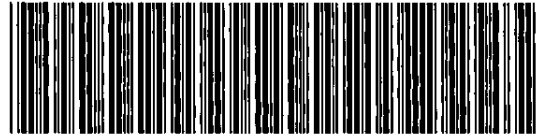

**ARTICLES OF ORGANIZATION
OF
MANIAC EINSTEIN, LLC**

The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is MANIAC EINSTEIN, LLC (the "Company").

ARTICLE II. PERIOD OF DURATION

The duration of the Company shall be perpetual, subject to termination in accordance with the Company's Operating Agreement or by the written agreement of the members.

ARTICLE III. ADDRESS

ARTICLE IV. REGISTERED OFFICE AND AGENT

ARTICLE V. MANAGING MEMBER

The business of the Company shall be conducted, carried on and managed by the Managing Member. The name and address of the initial Managing Member is William James Corio, 6759 Sugarbush Dr., Orlando, FL 32819.


ARTICLE VI. RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the membership of a member in the Company, the existence and business of the Company shall be continued by the remaining members without the necessity for the consent or vote of the members.

ARTICLE VII. OPERATING AGREEMENT

The power to adopt, alter, amend, or repeal the Operating Agreement of the Company shall be vested in the Managing Member of the Company.
