



QUALUS, LLC (A Florida Limited Liability Company)

Qualus, LLC (the "Company") filed its original Articles of Organization with the Florida Department of State on November 28, 2006 under the name Power Grid Engineering, LLC and was assigned Florida Document Number L06000113809. The Company filed its Amended and Restated Articles of Organization with the Florida Department of State on September 4, 2018 (the "Amended and Restated Articles").
