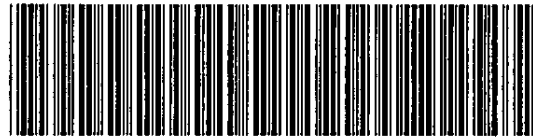

1. The date of filing the Articles of Organization was November 28, 2006.
2. The text of each amended Article is:

ARTICLE I

ARTICLE VII

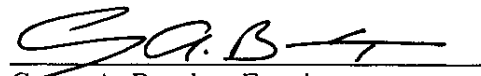
