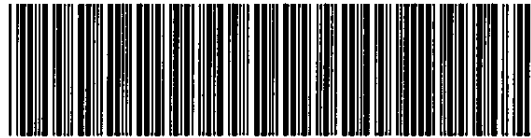

**ARTICLES OF ORGANIZATION
OF

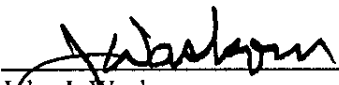
ARTICLE IV -- MANAGEMENT

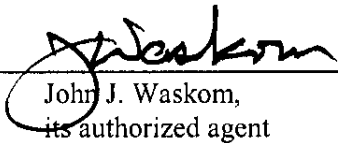
