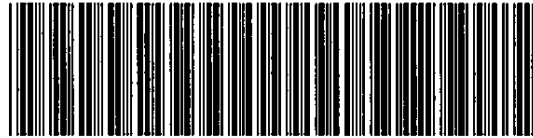



ARTICLE I
NAME

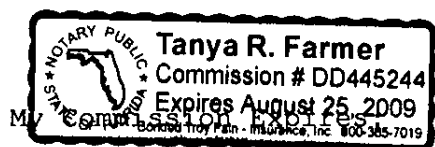


