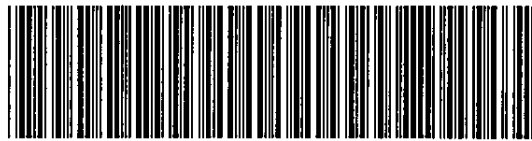



Articles of Organization

ARTICLES OF ORGANIZATION OF SCHULMAN · FRIEDMAN, P.L.

The undersigned certify that we have associated ourselves together for the purpose of becoming a professional limited liability company (the company) under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of professional limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the company.

ARTICLE I.
NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the company shall be SCHULMAN · FRIEDMAN, P.L., and its principal office shall be located at 2800 Weston Road, Suite 201, Weston, Florida 33331, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE II.
PURPOSES AND POWERS

The company is organized under this act for the sole and specific purpose of rendering professional legal services to the public. Only licensed attorneys in good standing with the Florida Bar can be members of the company.

In furtherance of the purposes and powers the company shall have the following additional powers:

1. To enter into and make all necessary contracts for its business with any person, entity, partnership, association, corporation, domestic or foreign, or of any domestic or foreign state, government, or governmental authority, or of any political or administrative subdivision, or department, and to perform and carry out, assign, cancel, or rescind any of such contracts.

2. To exercise all or any of the limited liability company powers, and to carry out all or any of the purposes, enumerated in these Articles and otherwise granted or permitted by law.

3. To do everything necessary, proper, advisable, or convenient for the accomplishment of any of the purposes, or the attainment of any of the objects, or the furtherance of any of the powers set forth in these Articles.

4. Nothing contained in these Articles shall be deemed or construed as authorizing or permitting, or purporting to authorize or permit the company to carry on any business, exercise any power, or do any act which a professional limited liability company may not, under Florida laws, lawfully carry on, exercise, or do.

ARTICLE III. EXERCISE OF POWERS

All company powers shall be exercised by or under the authority of the members, and the business and affairs of this company shall be managed under the direction of the members. This Article may be amended from time to time in the regulations of the company by a unanimous vote of the members.

ARTICLE V. MEMBERSHIP RESTRICTIONS

Only licensed attorneys in good standing with the Florida Bar can be members of the company.

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.


A member's interest in the limited liability company may not be sold or otherwise transferred except with unanimous written consent of all members.
