**ARTICLES OF ORGANIZATION
EL GUAMO INVESTMENTS LLC
A LIMITED LIABILITY COMPANY
(Pursuant to s. 607.407, Florida Statutes)**

Article 1- Name. The name of the limited liability company is EL GUAMO INVESTMENTS LLC.

Article 2- Purpose. The purpose of this limited liability company may include the transactions of any and all lawful business for which limited liability companies may be organized in the state of Florida.

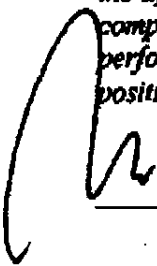
