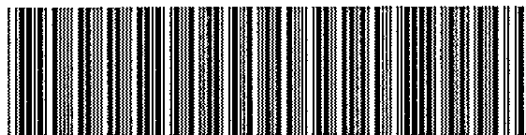

SECOND: This amendment is submitted to amend the following:


