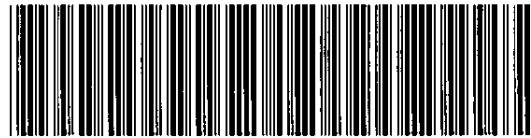

Article II. The Articles of Organization were filed on November 30, 2006 and assigned document number L06000114730.

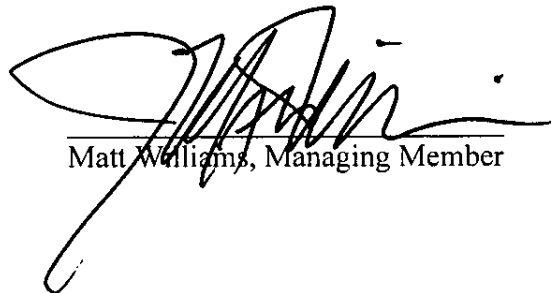
Article III. The dissolution was approved on 4/14/10.
