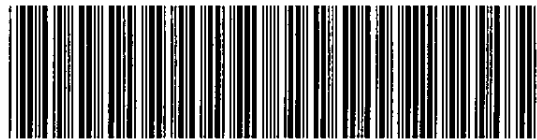



HEALING HYPERBARICS, LLC

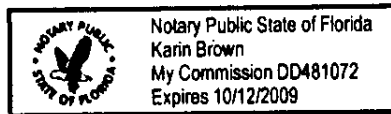
