The limited liability company is to be managed by one manager or more managers.

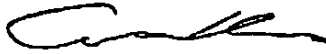

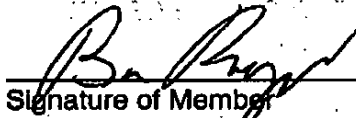
