**Article I
Name**

The name of the limited liability company ("Company") is **DA Freedom Tours, LLC**

**Article II
Address**

The mailing and street address of the Company's principal office is 36710 Bear Tracks Rd., Eustis, Florida 32736.

**Article III
Duration**

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

**Article IV
Purpose and Powers**

This Company is organized with a general business purpose, and has all powers provided by law and may use those powers to any lawful purpose.

**Article V
Registered Agent and Office**

**Article VII

Admission of any such additional members requires the written consent of all members then having any ownership interest in the Company. Any additional members are allocated gain, loss, income or expense by the method provided



**Article VIII
