ARTICLES OF ORGANIZATION for BOLD LEADS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME


participate in the management of the business and affairs of the Company or become a member except as such may be provided in the Operating Agreement of the Company.
