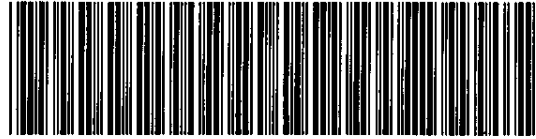



The Limited Liability Company is to be managed by its Managing Member. The initial Managing Member of the Limited Liability Company is Trent F. Huelle.


Articles V - Initial Member:

Pursuant to section 608.4235 of the Florida Limited Liability Act, no member of the Company shall be an agent of the Company solely by virtue of being a member.


