

## ARTICLES OF ORGANIZATION MANDEL FAMILY REALTY SF, LLC

OR ALL SAND The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file following Articles of Organization.

#### ARTICLE I -- NAME

The name of the limited liability company shall be Mandel Family Realty SF, LLC.
