ARTICLES OF ORGANIZATION

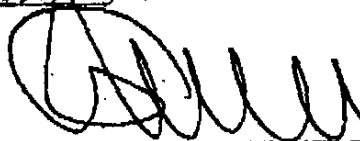
ARTICLE VI - MEMBERS

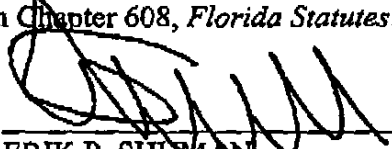
