ARTICLES OF ORGANIZATION OF THE HERITAGE, L.L.C.

ARTICLE I - NAME

The name of this limited liability company is The Heritage, L.L.C.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS
