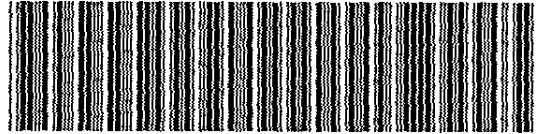

NAME**

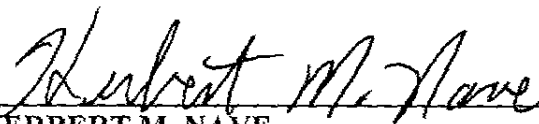
**ARTICLE VIII

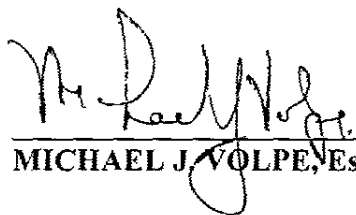
