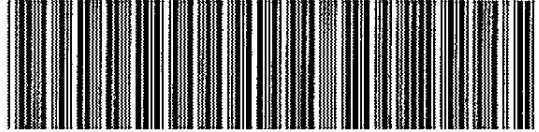

ARTICLES OF ORGANIZATION
OF
BEST SOURCE INVESTMENTS, LLC

Pursuant to §608.407 of the Florida Statutes, the undersigned hereby submits these Articles of Organization for the purpose of forming a Florida limited liability company:

1. The name of the Limited Liability Company is Best Source Investments, LLC.
2. The period of duration for the Limited Liability Company shall be perpetual, and the Limited Liability Company is authorized to engage in every trade, occupation, or profession and other lawful business, purpose, or activity, whether or not carried on for profit.
3. The name and address of each Authorized Representative of the members executing these Articles of Organization is as follows:



4. The Florida street and mailing address of the Limited Liability Company's initial Principal Office is: 602 West 27th Street, Sanford, Florida 32773, .
5. To the fullest extent permitted by the Florida Limited Liability Company Act as it exists or may hereafter be amended, *no person who is serving or who has served as a manager of the limited liability company shall be personally liable to the limited liability company or any of its members for monetary damages for breach of duty as a manager.* No amendment or repeal of this article, nor the adoption of any provision to these Articles of Organization inconsistent with this article, shall eliminate or reduce the protection granted herein with respect to any matter that occurred prior to such amendment, repeal or adoption.
6. The Limited Liability Company is to be managed by the member(s) who are designated, appointed, or elected to act as the managing members in accordance with the Operating Agreement of the Limited Liability Company. The managing members shall carry out and further the decisions and actions of the managing members made under the Operating Agreement and shall be authorized to execute and deliver any and all reports, forms, instruments, documents, papers, writings, agreements, and contracts, including but not limited to deeds, bills of sale, assignments, leases, promissory notes, mortgages, and security agreements and any other type or form of document by which property or property rights of the Company are transferred or encumbered, or by which debts and obligations of the Company are created, incurred, or evidenced, that are necessary, appropriate, or beneficial to carry out or further those decisions or actions.
7. With the written simple majority consent of the members, new members may be admitted into the limited liability company upon the payment of such capital contribution and upon such terms as the members decide by a simple majority vote. In the event that new members are admitted into the limited liability company, the share of each new member in the profits and losses shall be in such proportion as may be agreed upon between all the members and the new member.

The remaining members of the limited liability company shall have the right to continue business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the limited liability company as further set forth in the Operating Agreement of the limited liability company


