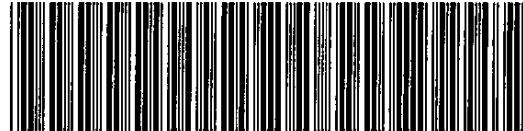

**ARTICLE I.

ARTICLE VI.


ADMISSION OF NEW MEMBERS


