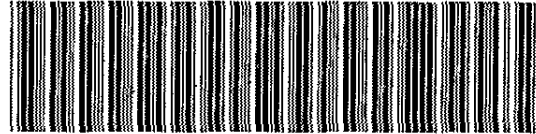

Article 1. Name of Limited Liability Company. The name of this limited liability company is Orellana Partners, LLC.

Article 2. Registered Office and Registered Agent. The initial registered office of this limited liability company and the name of its initial registered agent at this address are: Eric A. Lanigan, 222 S. Pennsylvania Ave., # 101, Winter Park, FL 32789

Article 3. Statement of Purposes. The purposes for which this limited liability company is organized are: any lawful purpose permitted under the laws of Florida.

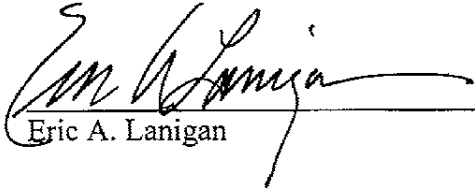
