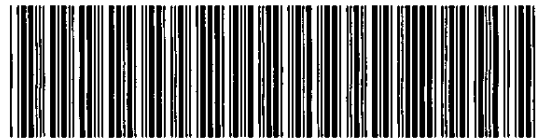



Article I be and it is hereby amended to change the name of the Limited Liability Company to: TJDJ INVESTMENTS, LLC.


