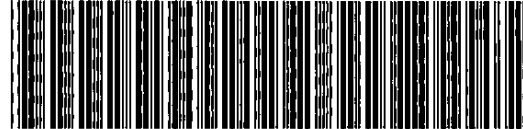

The principal place of business and mailing address of the Company is 4580 Julington Creek Road, Jacksonville, Florida, 32258.


ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS


